Sundridge with Ide Hill Parish Council

Minutes of an Extraordinary Council Meeting held on Monday 29 March 2021, 7.00 pm Remote meeting via Zoom

1. To receive apologies and reasons for absence.

There were no apologies.

2. To receive declarations of personal, prejudicial and disclosable pecuniary interests on items on the agenda and updates to members' register of interests.

Members agreed to wait for Mr Connolly, manager of Sundridge United Junior Football Club (SUJFC) to arrive at the meeting and took Agenda Item 4.0 before the public open session.

Members resolved unanimously to discuss Agenda items 5.1.2 and 5.2.3 in confidence.

The Chair invited members of the public to speak. Mr Connolly, manager of SUJFC, made a statement regarding SUJFC. He objected to the rise in the cost of the lease and the timing of the rise in hiring rates to SUJFC. Mr McGinn, Secretary of Ide Hill Football Club advised that the Club were still interested in hiring the ground for matches and offered to meet with Mr Connolly so they could work together.

 - 5.1 Rates and conditions of hire for Sundridge Village Hall
 - 5.1.1 To agree the hourly rates of hire for regular and casual hirers of the hall Members unanimously resolved to keep the hourly rates of hire for regular and casual hirers of the hall as agreed at the meeting on 18 January 2021.

Cllr Darby proposed that SUJFC be issued a licence starting on 30 March 2021 at reduced cost. Cllr Banbrook, De Bono, Darby and Powell voted for the proposal. Cllr Baker, Evans, Jones, Maybury and Miller voted against the proposal. Cllrs Allgood and Fribbens abstained from the vote. The resolution was not carried.

Cllr Baker proposed that the licence agreement for the recreation ground should be put out to tender for the start of the 2021/22 season with effect from 1st September 2021 and the licence fee decided by open competition from competing potential licensees. SUJFC being allowed to continue in occupation at previously agreed fee per month until the end of the 2020/21 season or no later than 30th June 2021

Cllr Baker, Evans, Fribbens, Jones, Maybury and Miller voted in favour of the proposal. Cllr Allgood, Banbrook, Darby and Powell voted against this proposal. Cllr De Bono abstained from the vote. This resolution was carried in the majority.

Members were in agreement that the Clerk should cancel the invoice for the soil bin and that Cllr Evans should advise Mr Connolly of the decision of the Parish Council.
