# Minutes of the Planning Committee of the Parish Council of Sundridge with Ide Hill in the Village Hall, Sundridge at 7.00pm on Monday 30 September 2019

In attendance were: Cllrs Allgood, Baker, Darby, Evans, Jones(Chair), and Kempster.

Prior apologies for absence had been received from Cllrs Powell and Furse.

There were no Declarations of Interest from any Members of the Committee regarding matters to be discussed at the meeting.

### **APPLICATION NUMBER: SE/19/02501/FUL**

Deadline: 1 October 2019

Site: Land Adjoining Dunbrik Waste Transfer Site 2 Main Road Sundridge KENT TN14 6EP

**Development:** Temporary use of land as a depot for civil engineering contractors.

The Parish Council were generally in support of the proposal for temporary use, but were concerned that, as the existing uses often result in traffic backing up onto the A25, particularly in the afternoons when refuse collection vehicles return to the site, the proposal of additional use by a number of large vehicles could exacerbate this problem. The parish Council would not object to this proposal provided the District Council are satisfied that the proposed additional traffic will not worsen the existing access problems.

### **APPLICATION NUMBER: SE/19/02571/HOUSE**

Deadline: 3 October 2019

Site: Woodcote Church Road Sundridge KENT TN14 6AT

Development: Erection of a double garage and home office and a single story rear extension with

internal alterations

The Parish Council were generally not against the proposal for the rear extension, but were concerned about the construction of a garage/office close to the front boundary and in front of the apparent established building line. For this reason, the Parish Council objects to the proposal.

## **APPLICATION NUMBER: SE/** 19/02628/FUL

Development: Erection of two storey detached dwelling with accommodation in roof space

The Parish Council considered that the proposed four-bedroom dwelling would be too large for this narrow infill site and failed to pay sufficient attention to parking provisions, which in this location are already insufficient to prevent extensive on-road parking and which the proposal would undoubtedly exacerbate. For these reasons, the Parish Council objects to the proposal.
