Report to Sundridge with Ide Hill Parish Council

18 July 2022

Covers Farm Quarry:

The tabling of this application at the KCC Planning Committee meeting has been delayed again; the earliest possible date for the meeting is now 7th September, although it may be delayed further.

If the application is on the agenda for the 7th September I will not be able to attend as I will be in Canada. Cllr Nigel Williams has kindly agreed to speak against the application on behalf of Brasted & Sundridge residents in my absence.

Residents are encouraged to attend the meeting to show their opposition to the application.

School Buses:

On the 7th of July, Kent County Council (KCC) announced the withdrawal of many of the bus services that local children rely on to get to secondary school. This includes the following routes which could be used by children who live in the Sundridge with Ide Hill Parish: S1, S41, TW1, TW3, TW4, TW6.

This is a terrible situation which is causing distress and frustration for many families. A solution needs to be found. My district council colleagues and I have been lobbying Kent County Council and Laura Trott to try to find a solution to this huge issue as soon as possible.

The key points:

- The commercial operator of these services (Go Coach) has decided to stop these routes due to them being loss making. This is in large part due to significant increases in fuel costs, a shortage of bus drivers and a decrease in bus ridership post Covid.
- There was temporary funding provided by central government to subsidise these routes during Covid, however, that money has now stopped.
- KCC doesn't have any funds to subsidise these routes to make them viable. Due to budget constraints KCC is already having to cut subsidies for other bus services.
- KCC has received government funding as part of the Bus Service Improvement Plan "BISP". However, the terms of the funding require it to be used for capital investment and improved provision, not subsidising or replacing existing routes.

Laura Trott MP has taken up the cause to get this resolved, as pupils must not be left without transport to school. She has written to the Department for Transport (DfT) to ask they work with KCC to ensure flexibility over the use of the BSIP money. She is also meeting with the Leader of KCC Roger Gough and the cabinet member responsible David Brazier to try and find solutions.

I will continue to chase this important issue.

Other:

Free Family Nature Trails:

Five, free eco-trails are being set up across the District so families can enjoy local wildlife during the school holidays.

The trails will be set up between 22 July to 4 September in Crockham Hill Commons, Farningham Woods, Hosey Commons, Oxenhill Shaw and Shoreham Woods. They'll explore some beautiful nature spots and be

filled with fun facts and quizzes along the way. The trails are self-guided and easy to follow, all participants need to do is turn up and have fun.

Everyone who takes part in a trail can win one of five eco-hampers.

4.1 School Bus Services

Here is an update on the Go Coach school buses to share with the PC.

This information is available from KCC on www.kent.gov.uk/buses

More details will be announced by KCC this week.

Just a quick reminder that Sevenoaks District Council is not directly or indirectly involved in buses so this just me trying to support residents with public information.

Here is what I have extracted from Go Coach's current position on school bus routes, from the KCC link.

- S1 Westerham to Knole Academy: still withdrawn but to be replaced with a modified S7 serving all Sevenoaks secondary schools
- S41 Edenbridge to Sevenoaks Schools: to be retained
- TW1 Kemsing to Tunbridge Wells Schools (through Bessels Green): passengers to use No 6 and change at bus station, however, this will not go through Bessels Green
- TW3 Shoreham to Bennett Memorial School (through Bessels Green): route modified so that it no longer goes through Bessels Green
- TW4 Westerham to Tunbridge Wells Schools: withdrawn, passengers to use 402W and change at Sevenoaks bus station onto TW3 or TW6
- TW6 Knockholt to Tunbridge Wells Schools (through Bessels Green): will continue but will be rerouted to travel through Sevenoaks before joining the A21 at Riverhill

11.1.1 Stubbs Wood Working Party

- Tim Saunders of Silva Woodland Management has been asked to carry out a survey at a cost of £500.00

I could undertake a review of the progress to date against the requirements of the annual WD2 management grant. This would comprise a detailed walkover inspection and a report with accompanying maps, reviewing each land parcel in terms work completed to date against the required prescriptions, with a recommendation for activity over the remaining years of the grant scheme. I think this would be necessary to provide a good baseline for work going forward, but it is also a requirement of the CS grant scheme (a 'progress review' in years 3 and 5 of the scheme can be requested by the RPA if the site comes up for inspection).

11.1.3 Sundridge and Brasted Social Club Working Party

- The Social Club Working Party will meet “face to face” in September.
- Members agreed that at the September meeting of the Full Council the Working Party would put forward a proposal of suggested next steps for the Social Club.

Council takes action to protect Sundridge woodland threatened with development

Sevenoaks District Council is taking action to protect a much-loved woodland in Sundridge, which is currently being sold for development.

The Council recently discovered the wooded site by New Road, Sundridge is being sold as individual plots with marketing information suggesting the land has the potential for development.

However, the woodland is in the Green Belt and is an Area of Outstanding Natural Beauty so planning permission for any residential development is unlikely to be granted.

To ensure the valuable woodland continues to be protected, the Council served Article 4 Directions today (Thursday 21 July 2022). These restrict the activities that can be carried out without planning permission including putting up fences, gates or walls, stationing caravans and other temporary uses and buildings.

Cllr Julia Thornton, the Council's Cabinet Member for Development & Conservation, says: "We have promised our residents that we will do everything we can to protect our much cherished environment. Serving these latest Article 4 Directions clearly demonstrate we are being true to our word.

"Anyone considering buying this land should beware: this woodland is protected and any proposals to develop it are highly unlikely to be granted planning permission."

This latest action comes after the Council served Article 4 Directions on sites in Shoreham, Cowden, Edenbridge, Penshurst, West Kingsdown and Sevenoaks as they too were being sold as individual plots for potential for development.
